Rule 5K-4.034, Florida Administrative Code was amended, and changes went into effect on March 12, 2025. The new requirements for hemp extract for human consumption provided in the amended Rule include child-resistant packaging that complies with ASTM International D 3475-20, Standard Classification of Child Resistant Packages.
